In accordance with pre-operational condition reference PO 2 in Table S1.3 of permit EPR/AB3101MW a document titled PO2 - Ambient Air Quality EMMP version 1 was submitted to the Environment Agency on the 9th February 2018 that described the ambient air quality monitoring strategy at Preston New Road.

Pre-operational condition reference PO 2 required the following to be submitted to the Environment Agency:

At least 4 weeks prior to commencement of the gas flaring activity the operator shall submit to the Environment Agency for approval a written Environmental Management and Monitoring Plan (EMMP) which will include, but is not limited to: details of the baseline air quality study undertaken prior to activities commencing; details of the ambient air monitoring programme proposed for during and after the period of gas flaring; and shall obtain the Environment Agency's written approval to the EMMP.

The issue of this compliance assessment report is confirmation of the approval granted to the document titled PO2 - Ambient Air Quality EMMP version 5.1.

The decision to approve this EMMP involved a detailed assessment process involving a panel of Environment Agency air quality and monitoring specialists.

In additional to providing approval of the EMMP the following key points are expected to be followed:

- Calibration of ambient air monitoring data against baseline assessment data.
- Targetted methane monitoring off site using the TDL500 instrument.
- Submission of the Leak Detection and Repair Programme to the Environment Agency for review.

Included in the EMMP is a summary of the Leak Dectection and Repair Programme. The full EMMP should be included as part of the site Environmental Management System.
